







ANNUAL REPORT 2020

Dear partners, friends and colleagues,

The preparation of an annual report provides an opportunity to reflect on the previous year – its success and challenges, and the lessons it taught us. While there are many aspects of 2020 I think we would all prefer not to dwell on, there certainly were successes to celebrate, challenges met and a plethora of lessons learned.

Of course, the most significant challenge arose early in the year. The global COVID-19 pandemic upended our plans as we pivoted to find new ways to support our partners and their work. With the help of our donors, US partners and supporters, we directed our Disaster Response Fund to support COVID-19 response. By the end of the second quarter of 2020, we had sent nearly \$50,000 to African partners and affiliate organizations to use in acquiring personal protective equipment (PPE), providing nutritional support for patients and their families and purchasing cellular data/ airtime to allow staff to work remotely. Thanks to a gift from a generous donor, we were able to offer \$10,000 in matching funds. We used this grant to match individual donations up to \$500 which helped ensure funding support to the greatest number of partners.

Our partners responded to the challenges of the pandemic with innovation and dedication. In Uganda for example, Rays of Hope Hospice Jinja (RHHJ) clinicians, nurses, drivers and social workers went out before a country-wide lockdown to cover each of the 21 patient routes, leaving before dawn and returning long after dark; every patient seen was provided with a stock of medicine for two months. The





teams also provided nutritional support packages to ensure that patients would have at least one nutritious meal a day. In Zimbabwe, Seke Rural Home Based Care used funds from their partner, Arkansas Hospice (which were matched by GPIC), to provide food and supplies like taped water buckets for hand washing with running water, face masks, latex gloves, thermometers and sanitizers to the families, along with their food hampers. One of the patients assisted was Diana, an 89-year-old widow living with dementia among other illnesses. Diana's daughter, and breadwinner of their family, Sophia, was unable to make a living due to COVID-19 lockdowns across the region.

The pandemic also highlighted the vital role advocacy plays in making sure palliative care services are available for those with life-limiting conditions. The Palliative Care Association of Uganda worked with its member organizations to ensure that palliative care was integrated into essential health services country-wide during the pandemic.

Collaborative efforts like this – and the many others that took place locally, nationally and internationally – illustrate the determination of the palliative care community to serve those in their care with compassion and dedication, regardless of the challenges they face. We offer our thanks to all of you for whatever role you played in continuing to enhance access to palliative care under difficult circumstances. Your compassion, dedication and advocacy for those in need of palliative care continues to inspire us. We appreciate your ongoing interest and support!

ABOUT US

VISION:

We envision a world where individuals and families facing serious illness, death and grief have access to essential services that afford comfort and dignity – which are human rights.

MISSION:

OUR WORK:

Global Partners in Care supports access to compassionate care by establishing partnerships, supporting research and education and working collaboratively to raise awareness of the global need for access to essential hospice and palliative care services.

Research and Education: We collaborate with institutes of higher education to advance research and grow opportunities for learning in palliative care.

Global Collaboration: We are committed to working collaboratively with our partnership organizations, national associations and the many important international organizations working to enhance access to hospice and palliative care around the world.





PARTNERSHIP PROGRAM

Our Partnership Program is guided by the belief that individuals and organizations can make a substantial and meaningful impact to enhance hospice and palliative care where the need is great. Each partnership is unique and GPIC supports organizations in developing, deepening and sustaining meaningful partnerships through individual and group consultations with GPIC staff, a library of resources and mentorship and guidance as needed. GPIC maintains direct relationships with relevant regional and national entities that support the work of partners such as the African Palliative Care Association (APCA) and national palliative care associations.

Key activities between partners include shared projects, expanding training and educational opportunities as well as learning from each other through exchange visits. Over the past two decades, GPIC and its partners have touched the lives of millions of individuals and families affected by AIDS, cancer and other serious illnesses. Since 2004, GPIC and US partners have sent nearly \$6.5 million (USD) to support the vital palliative care work of our partners on the ground.

COVID-19 RESPONSE

Like many organizations, nearly every activity we undertook was touched or directed by the pandemic in some way. GPIC was able to pivot activities to be responsive and still remain aligned to our mission. From March – October, we directed our Disaster Response Fund (DRF) to COVID-19 responses for our partners. In total, GPIC and GPIC partners sent nearly \$50,000 to palliative care organizations in Africa – including APCA and national associations - for COVID-19 response efforts.



Partner Highlight: Center for Hospice Care/Hospice Foundation and Palliative Care Association of Uganda

With news of the COVID-19 pandemic, Uganda was guick to implement mitigation measures – they announced lockdowns shortly before the first case was identified in the country. With a few days advanced warning, PCAU immediately mobilized to enable remote work for its staff – CHC sent \$500 to support internet and cell phone communication bundles so the staff could stay connected while working from home. Over the past few years, CHC had donated laptops to PCAU so all staff were equipped with one and they were ready to carry on their important work remotely.

Shortly thereafter, CHC/HF sent PCAU a \$10,000 grant to support their COVID-19 emergency response efforts. As a national association, PCAU has played a key role with member hospice and palliative care organizations across the country in preparing for COVID-19. Early in the pandemic, PCAU helped guide tactical and strategic planning and contributed to the national, district and community-level COVID-19 response in Uganda. These funds helped support education and training in infection control and prevention as well as securing PPE for hospice and palliative care providers across the country. GPIC also provided PCAU with a Zoom license to further enable communication among PCAU staff and members during the lockdown. This license also allowed PCAU to host regular virtual discussions with palliative care stakeholders in Uganda to share updates, best practices and take collective action during the pandemic.

The partners also worked together to secure a grant to help support PCAU's Road to Hope program, a program that supports the education and well-being of children who were caregivers for their dying parents. The funds helped provide educational support for the children while schools were shut down as well as some basic needs support for their families.

While the financial support has been crucial, sharing ideas and strategies for fundraising between the partners has also been important. CHC/HF started an e-newsletter to focus on its partnership initiatives with PCAU. PCAU also initiated a regular e-newsletter update to its constituents. The partners are regularly sharing ideas for improved communications and fundraising. Through this regular communication of sharing stories and raising awareness, the partners are elevating and supporting each other.

COVID-19 PARTNERSHIP RESPONSES

Many South African hospices rely on charity shops for some operational income. COVID-19 lockdowns required Khanya Hospice to scale back operations. A grant from their US partner, VITAS of Philadelphia, and GPIC helped fill the gap.

Before a national lockdown in Uganda, the RHHJ team mobilized to ensure patient care continuity with small stockpiles of medicines, food and other basic needs. A grant from GPIC helped RHHJ protect staff, volunteers and patients with PPE.

Our Lady's Hospice received additional financial support for much-needed PPE and other COVID-19 supplies, but they were most grateful for the encouragement and friendship from their partner.

EDUCATION AND RESEARCH

Global Partners in Care is committed to supporting research and education in global palliative care, and our work in this area continues to grow. In 2020, the pandemic posed unique challenges to engaging students as we have in the past. Despite travel cancellations, we continued to work virtually with students and faculty on a variety of topics related to palliative care including: nutrition, mHealth, elder care, policy development and partnership benefits. Student interns work with GPIC in several different capacities: conducting or supporting research, supporting program activities or providing technical support to our partners around the globe and working with us in our headquarters in Mishawaka.

African Palliative Care Education Scholarship Fund for Nurses and Social Workers

Given the various disruptions and shutdowns of educational programs in 2020, no scholarships were awarded. Funds allocated for 2020 scholarships have rolled over which will allow us to award a greater number of scholarships in 2021. Our plans for 2021 also include building a strategy with the African Palliative Care Association to grow the fund and increase the number of scholarships offered in order to better meet the demand.



COLLABORATIONS

American Academy of Hospice and Palliative Medicine

In April, we provided a membership to AAHPM to selected GPIC partners and collaborators. GPIC is a central point of support for these 30 memberships and is working with the AAHPM membership team to maximize the benefit to our partners and collaborators. Our expectation is that the person selected to receive this membership will utilize the connections and resources from AAHPM not only to enhance their own palliative care knowledge and efforts, but those of their organization as well. Many of the resources this membership offers will help our partners and they may also form new collaborations or networks that will enhance their work. Initial feedback collected from our partners showed that most participants found value in the membership, particularly in accessing publications, COVID-19 updates and the connections they made with colleagues online. These memberships will continue in 2021 with more targeted support from AAHPM We will conduct an evaluation of our members' use as well.

Bluegrass Care Navigators and the African Palliative Care Association

In early 2020, we embarked on a targeted engagement with the African Palliative Care Association (APCA) and Bluegrass Care Navigators (BCN) to support the organizational and strategic goals of APCA. BCN provides a 'disciplined coaching' approach to planning and implementation of the first year of APCA's strategic plan. We meet with members from both teams on a monthly basis to discuss different objectives in APCA's new strategic plan. This involves structured coaching from BCN to help APCA reach their strategic goals as well as identify challenges and create strategies to address them. Several new ideas and helpful connections have come out of these interactions. Simply having a 'thought partner' with whom to regularly discuss strategy has been noted as the main point of value between these partners!
